

REGULATIONS NOT HARMONISED AT EUROPEAN LEVEL

BICYCLES

SCOPE

Bicycle means any product which has two wheels and a saddle and is propelled mainly by the muscular energy of the person on the bicycle, in particular by means of pedals.

The objects subject to the provisions of Decree No 89-662 of 12 September 1989 on the prevention of hazards from the use of toys are not subject to the provisions of the Decree below.

Electrically power assisted cycles (EPAC) are also subject to these regulations (power limited to 0.25kw and assistance activated in response to pedalling force, up to 25 km per hour).
