

REGULATIONS HARMONISED AT EUROPEAN LEVEL

BIOCIDAL PRODUCTS

SCOPE

'**Biocides'** means active substances and preparations containing one or more active substances, intended to destroy, deter render harmless, prevent the action of, or otherwise exert a controlling effect on any harmful organism by chemical or biological means.

The regulation stemming from European Directive 98/8/EC details the terms for the placing of the said substances and products on the market and the mandatory prior authorisations.

The terms can be found in Chapter II - Title II - Book V of the Environmental Code ([**Articles L. 522-1 et seq.**](#)).

The regulations apply to the biocidal products listed in the Appendix to [**Decree No 2004-187**](#) and do not apply to the substances listed in [**Article L. 522-1 – III**](#) of the Environmental Code.
