

**REGULATIONS NOT HARMONISED AT EUROPEAN LEVEL****OUTPUT LASER DEVICES****SCOPE**

The following definitions apply :

- Laser: any device that can produce or amplify laser radiation whose beam is accessible;
- Laser radiation: any electromagnetic radiation within wavelengths ranging from 180nm to 1mm, produced by controlled stimulated emission ;
- Laser devices: any device or any combination of components that makes up, incorporates or is intended to incorporate at least an output laser or a laser system.

**These provisions do not cover :**

- Laser devices such as CD readers since the device must be closed to operate in normal conditions, meaning the laser is inaccessible

**FRENCH REGULATIONS**

- [Decree 2007-665 of 2 May 2007 modified](#) on the safety of laser emitters

**EUROPEAN REGULATIONS**

Certain output laser devices may be covered by :

- [Directive 2004/108/EC](#) on the approximation of the laws of the Member States relating to electromagnetic compatibility
- [Directive 2006/95/EC](#) on harmonisation of the laws of Member States relating to electrical equipment designed for use within certain voltage limits
- Specific regulations (For example speedometers covered by Measuring instruments Directive)

Output laser devices not covered by the n° 2007-665 modified Decree and outside the scope of the Directive 2006/95/EC (Low voltage) are a matter of the general obligation of safety of products (cf. Directive N° 2001/95/EC transposed into the article L 221-1 and following ones of the French consumer Code)
