

**REGULATIONS HARMONISED AT EUROPEAN LEVEL****LIFTS****SCOPE**

Lifts for residential building, freight elevators solely for objects, and whose cars are accessible to persons who have a control button within reach, permanent lifts installed in building and their safety components.

The essential safety requirements for new lifts installed in sustainable buildings and their safety components for the prevention of hazards stemming from lift design and construction, which make it possible to check compliance with the essential requirements, are defined in the regulations.
