

REGULATIONS HARMONISED AT EUROPEAN LEVEL

PERSONAL PROTECTIVE EQUIPMENT

SCOPE

Personal Protective Equipment (PPE) for professional, sports or recreational use

Examples: air purifying respirators protecting against solid or liquid aerosols or dangerous or radiotoxic gases; diving equipment; personal protective equipment intended to protect against falls from a height; solar safety glasses, and so on

The scope of the Directive does not apply to: PPE specifically designed and built for the armed forces or law enforcement (i.e. helmets, shields); self-defence PPE against assailants (i.e. aerosol spray cans, individual weapons for the purpose of deterring assault).

The Directive lays down the conditions governing the placing on the market and the free movement within the Community and the basic safety requirements, which PPE must satisfy to ensure the protection of users' health and ensure their safety directive.
